General Information

All RV parking for OHSAA State Football will be sold in advance of the event. Permits are \$50/day for the event. Permits may be purchased <u>HERE</u>.

All RV parking spaces are numbered and pre-assigned. RV parking passes WILL NOT be for sale on the day of the event.

The RV lot will open at 7am on Thursday, December 4. For guests arriving early, parking is available at the Ohio State Fairgrounds on Wednesday evening. Please contact 614-644-4567.

RV's and vehicles-in-tow must vacate the lot by 6am on Sunday, December 7. If a vehicle remains in the lot, it will be towed at the owner's expense.

Alcohol Policy

Possession and consumption of alcohol are subject to the laws and regulations of the State of Ohio and/or City of Columbus which state, among others: No person shall have in the person's possession an opened container of beer or intoxicating liquor in any public place.

Law Enforcement Officers enforce all applicable laws.

Auto Assistance

As a service to Ohio Stadium guests, limited complimentary vehicle assistance may be available in any campus parking lot or garage. Service is available before, during and up to one hour after any event. Please contact University Police at 614-292-2121 for assistance on game days.

Canvasing/Advertising

Companies are prohibited from distributing free or sample products without the approval of The Ohio State University. Those who wish to organize and provide such sites or services should contact the Department of Athletics at 614-292-1848 for permission.

No bills, signs, banners or tent frames may be attached to University furniture, trees, or light poles. Freestanding signs must be secure and safe, and be no larger than 4 by 4 feet. No signs causing ground penetration are permitted without prior approval.

Directions to RV lot

From the North:

Take SR-315 south, exit at Ackerman Road and turn left onto Ackerman Road. Turn right onto Fred Taylor Drive. Turn left into the north end of the RV lot, just past Jesse Owens Memorial Stadium.

From the South:

Take SR-315 north, exit at Ackerman Road and turn right onto Ackerman Road. Turn right onto Fred Taylor Drive. Turn left into the north end of the RV lot, just past Jesse Owens Memorial Stadium.

Golf Carts

Use of golf carts on road ways and on campus is not permitted.

Grilling on Campus

No charcoal grilling or open fire pits are permitted on the OSU campus. Liquid propane grills are permitted on campus as long as safety protocols are adhered to:

- 1. Ensure a fire extinguisher is available for use in case of fire or flare-ups (do not "borrow" them from other buildings)
- 2. Propane grills must be placed at least 10 feet from structures and should not impede walkways or means of egress
- 3. Propane grills must be placed atop a shield, to protect the surface beneath from drips/spills
- 4. Use a propane grill on a level surface, avoid inclines and uneven ground
- 5. Place a propane grill away from brush, trees, foliage or other combustibles

Guests who are interested in setting up tents or inflatables and grilling at their tailgate should adhere to the OSU Emergency Management and Fire Prevention policies outlined at www.go.osu.edu/tent.

Pets

All pets are expected to be on a leash. Guests are expected to clean up after their pets.

Services

Water and dumping service will be available on Friday and Saturday morning from 8:00 am – 10:00 am. Please contact Rent-a-John at 614-989-2487 to schedule your water or dumping service.

Water service will be \$25 per RV. Dumping service will be \$35 per RV.

Each party is responsible for scheduling their own dumping or water service.

Shower facilities will not be provided.

Severe Weather

In case of inclement weather, guests are expected to follow the direction of OSU Public Safety and/or Event Management officials.

Smoking/Tobacco Policy

The use of all types of tobacco products (including and not limited to, cigarettes, electronic cigarettes, cigars and cigarillos, hookah smoked products, pipes, oral tobacco and nasal tobacco) is prohibited in all university buildings and on all university-owned properties, including parking lots, garages, and all outside areas. This also includes any product intended to mimic tobacco products, contain tobacco flavoring, or deliver nicotine other than for the purpose of cessation.

Tailgating

Trailers, storage units, and tailgating activities may not take up vacant parking spaces or interfere with traffic flow within a parking lot. Drive lanes in parking lots must be maintained at all times. Guests are responsible for the functions they host in their parking spaces. Vehicle and tailgate must fit within the red lines.

Tents/Camping

The use of camping tents is not permitted.

No tents or fencing requiring staking may be set up without prior approval. It is recommended that expandable 10x10 "pop-up" tents be used when possible. Tents may not cover grass for more than 24 hours.
