## PRIVATE INSTRUTION

Players on school volleyball teams ARE permitted to receive individual one on one instruction by non-school trainers' or instructors during the season of play. However, an important 'safeguard' to this is the permission for school coaches to deny it if they so choose.

And...be careful that this does not violate the non-interscholastic rule. If the 'private instructor' is the player's club coach, we strongly would recommend that you check with your school's Athletic Director to ensure that this participation does not violate the non-interscholstic participation regulation found in GSR

#### **COACHES STANDING**

NFHS VB Rule 12-2-6 extends the privilege of standing to coach in the libero replacement zone to the **head coach only**. The note, which follows this rule, confirms that interpretation. Article 5 stipulates specifically the only times that assistant coaches may rise from the bench during a set. The penalty for this infraction is unsporting conduct.

# RULES MEETING REMINDER - FINAL NOTICE OF FREE MEETING

Please take note that the complimentary rules interpretation meeting, which is mandatory for high school coaches and officials, closes at midnight on August 29 – ONE WEEK FROM TODAY! Failure to complete this requirement means that your school will be INELIGIBLE for the OHSAA tournament. Officials shall be suspended for non-compliance.

# 2015 SCHEDULE

Please note that although the Board has adopted a consistent start date for practice – August 1 – the start of regular season matches rotates depending on the way that the calendar falls. Although you athletic administrator probably schedules most of your matches, note that the start date for contests in 2015 is August 22 which is six days later than the comparable August 16 start this season.
