**REQUEST FOR TRANSFER INSTRUCTIONS RE. BYLAW 4-7-5**

**Revised – November, 2011**

**BYLAW 4 – SECTION 7 – TRANSFER**

*4-7-5 Notwithstanding the provisions of sections 4-7-2 and 4-7-4, if a student transfers pursuant to state or federal statutes addressing unsafe schools or academically poor performing schools, and the student can demonstrate to the satisfaction of the Commissioner's office that the transfer is for purely academic reasons and not athletic reasons, the Commissioner's office may declare such transferring student eligible upon application to the Commissioner's office.*

*The student is not eligible until declared eligible by the Commissioner's office. **Note: The student shall be entitled to one transfer only under the provisions set forth in this bylaw.***

The following High Schools identified within the categories of either academic watch (AW) or academic emergency (AE) and referenced as “**academically poor performing schools**” within this bylaw for two of the past three school years, are listed below for the 2011-12 school year.

**To request an eligibility ruling, a school administrator representing the school into which the student is transferring must send a letter identifying the following:**

- 1. Name of the student**
- 2. The high school from which the student is transferring pursuant to 4-7-5 and which appears on the current list.**
- 3. Verification that the transfer is being made for purely academic and not athletic reasons and that there has been no contact with the student by any member of the athletic department staff for the purpose of encouraging the transfer.**
- 4. Verification that this is the first and only transfer pursuant to 4-7-5.**
