An official who has renewed an officiating permit may transfer to an inactive status for reasons related to employment, medical, family or other hardship. Application must be made to the District Officials Secretary prior to the opening date of the sports season (first date games can be played). When making such application the official agrees: 1) He/She is ineligible to renew: class 1 or 2 permit for the ensuring school year. 2) Not to officiate any contests requiring an OHSAA officials' permit during the current season. 3) Failure to abide by this agreement will result in the suspension of all officiating priviledges in all sports for a maximum of five years. The official may obtain a Class 1 or 2 permit for the ensuring school year by following the unsupervised testing procedure in the Handbook for Officials and on the website.
