## BYLAW 4-7-2, EXCEPTION 9 FORM – 2019-20 SCHOOL YEAR TRANSFER TO THE PUBLIC HIGH SCHOOL IN DISTRICT OF LEGAL CUSTODIAN'S RESIDENCE

**INSTRUCTIONS:** This form is to be completed **BY A SCHOOL ADMINISTRATOR**, with assistance from a student's family, when a student transfers to the public high school located in the public school district within which the student's residential parent/legal custodian has resided for a minimum of one year, regardless of whether the student is transferring from a public or nonpublic school. A student is entitled to just one transfer under this provision. The student will continue to be held accountable to the transfer consequence until declared eligible in accordance with the submission of this form. Please note that exception nine cannot be used to transfer from the public high school of the district in which one parent resides to the public high school of the district from either a public high school in a different district or a non-public high school, in order to use this exception the student shall be assigned (in accordance with OHSAA business rules) or transferred to the high school located in the parents' attendance zone, or, if there are no defined attendance zones, to the high school which is closest to the parents' residence.
