Participation in the Rules Process

A note to coaches that you will be asked to participate in the NFHS Rules Writing Process in the next several days. I will go into more detail about the process itself in a coming "Rebounder's Report", however, the first significant step the NFHS utilizes is a nationwide questionnaire of coaches, administrators and officials relative to current and potential new rules. Coaches with email addresses in *my*OHSAA will receive an email in the coming few days asking them to participate in this all-important step.

Take Note of Uniform Regulations

Rule 3-4-1c in the NFHS Rules Book: The torso shall be white for the home team.... "White Outs", "Black Outs", wear Green to save the Trees. White is required at home. It is NOT permissible to wear "Black" at home (for example) to be part of a "Black Out" night at school. Many rules get intertwined and 'intentionally' confused with "school spirit". As covered in this year's Rules Interp. Meetings; only special occasions such as 'pink' are permitted on a case by case basis AND WITH APPROVAL from the OHSAA. Only last year was the permission granted for THESE special events and we do so on a very limited basis. This insures that all other uniform regulations (numbering, size of numbers, etc.) remain intact as the rule is intended.

Rule 10-5-4 of the Rules Book indicates: The head coach shall not permit a team member to participate while wearing an illegal uniform (see 3-4 indicated above). PENALTY: (Section 5) Two free throws plus ball for division-line throw-in. The foul is charged directly to the head coach. (Art. 4) Penalized when discovered. Only one technical foul is charged regardless of the number of offenders.

Just something to take note; Sportsmanship and the integrity of the written rules overshadows what some may indicate are "school spirit".

Making Up Regular Season Games

I am often asked about the eligibility of a Freshman player who competes in a Freshmen tournament and whether or not he/she is eligible to 'move up' and dress (and possibly participate) in the OHSAA Sectional Tournament. Will he/she 'run out of quarters'?

Game Administration

I have mentioned several times throughout the season the importance of addressing 'game security'. Of course, the worst gets attention in the media, however, each time it is in the public's eye, it serves as a reminder to be diligent about security at contests. Though this is certainly a 'game administrator's' role, I also know MANY of you serve in dual roles as coach/athletic director. Since ALL coaches are concerned about games running 'smooth', these may also be some points to sit down to review with your Athletic Directors:

- Make sure Officials have adequate security leaving the court, their locker rooms are 'guarded' at halftime and after games and there is adequate security leaving the facility. Often, the latter is ignored.
- Half-time activities. No doubt, everything from 'donkey basketball' to 'shoot for a buck' occurs at halftime of games. A reminder first that halftimes are NOT permitted to be extended for events. Review your procedures for 'clearing the floor' after these events occur. A team coming out of the locker room should be given TOTAL priority for warm-up for the second half. Raising funds is critical for everyone, but we should also remember why we are there in the first place.
- Point of Emphasis on keeping the floor 'clear'. Those that interfere with warm-up and the game itself should be kept clear of the playing floor.
