New Divisional Alignments Being Calculated

No doubt, most coaches want to know how soon the 'new 2 year alignment' will be complete. The divisional breakdown in basketball (4 divisions) all begins with the official count of the number of boys' and girls' that are in a school. Here are a few facts about 'the count':

- The count is based upon a count submitted to the ODE in October of 2010.
- The count includes students in grades 9-11 in October of 2010.
- The count is done separately; the number of boys and the number of girls
- Schools are provided this number first and given a chance to challenge any errors that may have occurred in the reporting to the ODE.

Can the count be 'manipulated' to help a school?

No. The importance of using the official count from the ODE prevents a school from 'having their cake and eating it too'. Each school in Ohio receives a just over \$5,800.00 per student from state foundation money. Obviously that money is important, so no school is going to 'miss' a student in their count. However, *most* coaches would like to see that count LOWER. (lower count = lower division). Since the state foundation dollars are tied to the official count, the number is not one that can be altered simply to benefit a schools' athletic potential success. You can imagine this scenario when our divisions are released: Divisions are released and a coach calls indicating we should not count a certain number of students. The next phone call comes from the Superintendent indicating "you BETTER count those students....that is money to our school".

How are the DIVISIONS actually calculated?

An interesting question. Once the official numbers for all schools are provided, all schools that participated in the 2011 tournament are listed in descending numerical order. Let's use the easy example that 800 schools participated in the 2011 tournament. It is easy to 'draw a line' every 200; giving an equal 200 teams in each division. This is done separately for boys' and girls' so it is possible for a school to be Division I in boys (for example) and Division II in girls. Actually, there were 803 total boys teams used for the last 2 year cycle and 798 girls teams. Believe it or not but every year there are schools that sponsor a varsity basketball team that actually do not participate in the tournament. This doesn't happen as often in basketball as it might in some other sports.

What about "ties"?

No doubt. There COULD be two schools that tie with the same number of boys for example. For example, with a theoretic cutoff of 128 boys and below for Division IV, if there were 3 schools that had 128, it might possible lead to an additional 1 or 2 teams in Division IV and 1 or 2 less in Division III. That is why for the 2009-11 divisional breakdown, the following exists:

Boys	Girls
Division I: 200 schools	Division I: 199
Division II: 200 schools	Division II: 200
Division III: 201 schools	Division III: 199
Division IV: 202 schools	Division IV: 200

What about the "Competitive Balance" proposal?

No doubt, most coaches are now aware of the referendum item to be voted upon by member schools that offers a solution to 'competitive balance'. IF approved by the member schools, this would occur no later than the 2013 school year. More to come on this.
