All COACH Rules Meetings Required ONLINE for 2013

Private Instruction

OHSAA Sports Regulations DO permit players to receive INDIVIDUAL instruction during the season of play but only with your approval. I caution coaches on this, however. It does NOT give the permission for players to participate in workouts (disguised as "instruction") with their club/travel/noninterscholastic teams. Generally, if the individual is paying for instruction it probably meets the permission.

Scrimmage Note

With a relatively 'short' preseason in soccer, if you have any of your 4 permitted scrimmages remaining when your regular season starts – you MAY use scrimmages anytime throughout the season.

Important Note on Previews

Teams are permitted to schedule 1"Preview" if they wish to do so. Previews are clearly defined and MUST be one HALF in length (40 min. Varsity) Admission may be charged and can be held between August 12 and the date of your first game.

Alumni Scrimmages?

Many teams elect to hold an "Alumni Scrimmage. This is permissible since Ohio remains one of the few states that permits its schools to play teams that are not members of the state association. Please note. however, any Alumni Scrimmage is just that...1 of the 4 permitted scrimmages. Of course if you do this as 1 of the 10 permissible Instructional Days in June/July, the 'event' would not be considered an OHSAA event.

Concussion Legislation Reminders

Please be cognizant of the signs and symptoms of concussions and even though you are required to complete the NFHS Concussion Course when you renew your Pupil Activity Permit, why wait? Take it now.

The Non-Interscholastic Rule - An Explanation

Soccer coaches received an email last week noting a reminder about the Non-Interscholastic Rule and how it affects attendance at "ID Camps". As a result, MANY of you emailed me and stated that it was appreciated and understood now, however, what does the "September 23 Non-Interscholastic Date" mean? It seems to contradict the information I sent out. Great question and there are 2 important parts to the answer:

A "Special Event" Game?

More and more, teams are electing to participate in a 'game for a cause'. While both the



NFHS and OHSAA wish to commend and support the efforts of players and coaches for these events, a few guidelines exist. First and foremost, the requirements for the way in which jerseys/shorts are NUMBERED must remain. In other words, there must remain a 6" number on the back of the jersey and a 4" number on the front of the jersey OR

Non-Interscholastic Warning #2

Once players establish themselves as a member of your school team by playing in a scrimmage OR a game, they are not permitted to tryout, practice or compete with ANY non-interscholastic program – including the "College ID Camps". Please take a moment in your practices and REMIND your players.
