Any school failing to meet this requirement will be ineligible for tournament competition.

It will be the responsibility of the head coach, assistant coach, or athletic administrator of each school to be in attendance within 10 minutes of the start of the meeting and stay until the conclusion of the meeting in order to receive credit for attendance.

2007 BOYS TENNIS RULES INTERPRETATION MEETINGS

By OHSAA Board of Control regulation, any school sponsoring interscholastic contests in Boys and Girls Tennis must have the head varsity coach, assistant coach or athletic administrator attend one of the meetings listed below. There must be a head coach, assistant coach or athletic administrator for the girls team and a head coach, assistant coach or athletic administrator for the boys team in attendance. Any school failing to meet this requirement will be ineligible for tournament competition.

It will be the responsibility of the head coach, assistant coach, or athletic administrator of each school to be in attendance within 10 minutes of the start of the meeting and stay until the conclusion of the meeting in order to receive credit for attendance.

Note: If the head boys varsity coach, assistant boys coach or the boys athletic administrator attended a Tennis Rules Meeting in the Fall of 2006 and turned in a registration form, that school is not required to attend one of the Boys Tennis Rules Meetings. Any school failing to meet this requirement will be ineligible for tournament competition.
